Why do some patients have a co-pay on their chronic medication?	<p>Co-payments can be avoided by:</p> <ul style="list-style-type: none"> • Ensuring the patient makes use of the Designated Service Provider (DSP) • Ensuring that the patient is registered on the Chronic Programme • Prescribing in-formulary drugs • Asking the pharmacist to substitute expensive medications with a generic equivalent that will attract a co-payment • Prescribing in-formulary drugs
Why is the Day-to-day limit not sufficient for the medication that is needed?	<ul style="list-style-type: none"> • Payment of medication is subject to Scheme Rules • Member's day-to-day benefit may have been exhausted
Why does medication that is prescribed by doctors gets changed at the Pharmacy?	<p>The Pharmacist may need to change prescribed medication if:</p> <ul style="list-style-type: none"> • If the medication prescribed by the HCP is not on the Bonitas formulary • If the pharmacy does not have the specific drug in stock • If the patient requests more affordable medication
